Seven members from the CIB Mumbai Chapter met on the first Saturday of February to look at how to take off the plans that had been in the drawing board stage for a few months now. Charting a Roadmap

Eight delegates came together on a sunny Friday afternoon, deliberating over cups of coffee and tea on the long-term goals and short-term tasks for CIB's Bengaluru chapter.

B R Nagaraja coordinated the meeting held at Siemens office in central Bengaluru.



Sarosh Ghandy and Dilip Patel reiterated the objectives of CIB, while referring to the biennial CIB conference that is scheduled for January



2016. The discussion initially revolved around the subtle difference between legal compliance and ethical behaviour.

Mr. Ghandy emphasized on the importance of roping in a few 'champions' – people who have standing



in the industry and share common values. Ashok Swaminathan stressed on the importance of reaching out to 15–20 leading organizations and make them 'members'. A list was compiled of organizations in the city that have links to Initiatives of Change.

Prabhu Shankar narrated the background behind his coming to the meeting, after taking permission for half-day leave from his workplace. AVR Rao and Manjunath shared their views about how CIB Bengaluru chapter could expand its reach.

A decision was taken to approach organizations in person, along with brochures and material about CIB. Mr. Patel proposed a small-group meeting on or around March 9 to discuss further the plan to visit organizations and enrol new members.

A small team gathered around a table at the IofC flat in Kumaram at Worli Seaface in Mumbai on February 20, 2015 for the CIB India Working Group meeting. Looking ahead at the next Biennial CIB Conference scheduled for January 2016, the team discussed ways at which the Conference could be made meaningful and impactful.

Another matter of discussion that took place was on conducting two or three Round Tables (RT) in India for business leaders to deliberate on much the same thing as that in the conclave. Recognizing that the ones who participate in the Conclave in January 2016 would not be the ones at the RT, it was hoped that the deliberations could help broaden the base.

Looking at strengthening CIB in the regions where CIB has its presence, a few meetings in some countries were also looked at. To begin with CIB Malaysia has planned a RT with business leaders in the last week of March. Visits to two countries in Africa have also been decided on. The hope from these efforts is that it would not only reinforce the work of CIB in these regions but also serve to encourage many to participate in the January 2016 International Conference.

CIB (South Korea) Round Table



CIB Korea co-hosted the first CIB Round Table (RT) in Seoul with Human Development Institute on November 20, 2014. The theme was "Sustainability and Ethical Practices in the Corporate". Sarosh Ghandy (India), Director,

CIB and Folker Mittag (Germany), member of CIB supported the occasion.

Sarosh presented his opening remarks and also shared his experiences in what he had learnt and practiced while he was working with the conglomerate, TATA Ltd. 30 CEOs/MDs participated with 10 Observers. The program was sponsored by TATA-DAEWOO.

Though CEOs/MDs were surprised that there was no Key Speaker, everyone had an opportunity to share their challenges and solutions in the course of their business. One shared about the temptation of

using a company credit card for food when it went over \$30. Another shared about the treatment for one's employees.

We all realised how important the translation was. We underestimated the language problem during the RT. All

foreigners noticed the cultural differences between Korea and their countries.

Following this RT, Sarosh, Folker along with Yeonyuk paid a visit to the TATA-DAEWOO commercial vehicle plant in Gunsan on the southwest coast of Korea. They also met and discussed ethical management in Korea with Moon, Kook-hyun, President of Hansol Textile, who is nationally known as a businessman with ethics; and Joern Elbracht, General Manager & Regional Compliance Officer of SIEMENS Korea.

After the RT, the Organisers stated that the next important steps have to be CIB-team building and an RT follow up. Support from CIB International was offered on technical items. It is hoped, that with personal friendship and support the CIB team in South Korea would be made strong.
