## Ethics for Internal Auditors A Report



On December 4, 2018 at 3:00 pm, a webinar was organised by the Institute of Internal Auditors on ethics for internal auditors. The purpose of The Institute's Code of Ethics which is to promote an ethical culture in the profession of internal auditing said that a code of ethics is necessary and appropriate for the profession of internal auditing, founded as it is on the trust

placed in its objective assurance about governance, risk management, and control.

In this webinar, Principles and Rules of conduct were discussed along with case studies. This webinar which was meant for Internal Audit Managers (who manages a team) listened to S. Venkatesh, Head - Risk and Internal Control (Regional Hub South Asia), Siemens Limited talk on the subject. Venkatesh is a qualified cost and management accountant, a certified information systems auditor and an alumni of IMD Switzerland. He has 29 years of experience in Business Process Consulting, Information Technology (Governance, ERP Implementation, Information Security), Enterprise Risk Management, Internal Control Systems. He was involved in one of the first implementations of Sarbanes Oxley Compliance in India in 2003.

Venkatesh who is currently the Convenor of the Mumbai Chapter of Initiatives of Change for Business, an organization dedicated to promoting ethics in business and industry is also the co-Founder and Convenor of RMNEXT – an informal network of CROs and ERM professional across industries.

At Siemens he is currently responsible for managing processes in the areas of Governance, Enterprise Risk Management, Internal Control System (including Internal Financial Controls) and Legal Compliances across Siemens companies in South Asia – a role that he has been handling over the past nine years.

Following the webinar, several persons provided their feedback. Cyrus Adajania from J. P. Morgan said it was, "Very interesting and practical concepts." Chetan Thakker of JSW Ltd. called it a "good show." Ratul Neogi, Tata Trent, said, "Thanks for taking the time for this Webinar. ## Meeting with Pune Chapter Team A Report

It was a pleasant morning on December 15, 2018 when twelve persons met together at the Forbes Marshall Guesthouse at Satellite Towers, Pune. The focus of the meeting was to explore ways in which the work of Initiatives of Change for Business (ICB) could be strengthened within the Pune Chapter.

Sarosh Ghandy who had travelled from Bangalore to join with the core team members of the Pune Chapter chaired the meeting. He first provided a background of the road that ICB has taken since the early 2000's and how it has evolved to its present state. He then went on to explain why the need for a change of name was felt from the erstwhile Caux Initiatives for Business (CIB) to its present name ICB. The meeting which coincided during the



period where the Pune Chapter team witnessed a change of Guard, Sarosh thanked Lt. Col. Allan Burby (Retd.) who had worked hard as Convenor and T P Mukherjee, Burby's predecessor for their leadership. He then welcomed Mohan Nair who recently took on the mantle and Shriwardhan Gadgil who would support him as Co-lead for the next two years.

Mr Ghandy has always been a strong advocate of knowing who your flock are. Therefore, the team considered the entire issue of Corporate membership. The team offered to meet in a week's time thereafter to consider the various nuances that it would entail from a pan-India perspective.

Mr Ghandy then spoke to the team about the proposed CEO Conclave that was being planned in April 2019. He spoke of the section of industry that were being targeted and the theme for the Conclave. An in-depth discussion helped consider the topic in greater detail.

Luis Gomes who had travelled from Goa to meet with Sarosh Ghandy and the Pune Chapter team then led the next part of the meeting that involved reflection and introspection. After all were given the time to ponder and note down their thoughts, each one in the team spoke of what they thought added to the strength of the Chapter and what were the challenges that they faced. This honest time of reflection brought about an opportunity for the team to consider their way ahead.

Before the meeting concluded, Farhad Forbes, Joint Chairman of Forbes Marshall Pvt. Ltd., Pune and Vice Chair of ICB shared that:

- ICBs USP is ethical leadership and values. It should use the guiding principles to solve specific problems where sustainability, environment, social, community and local employment are included.
- He also highlighted not to leave the large companies out as they need to be sensitized in taking full responsibility, including that of contract labour.
- He also said that by being ethical in business, it should benefit the business as well as society.

## ICB India Working Group Meeting A Report



December On 14. 2018 Sarosh Ghandy, Chairman of Initiatives of Change for Business (ICB) visited Pune Bangalore from to meet Farhad Forbes, loint with Chairman, Forbes Marshall Pvt. Ltd., Pune and Vice Chair of ICB. They were joined by Luis Gomes from Goa and Charles Fernandes from Panchgani,


both from the ICB Secretariat.

Various matters were considered, one of which was the creation of a "visioning committee" that could assist the ICB Chair and Vice Chair in their efforts to lead ICB.

The four of them also deliberated on ICB's purpose and what role it could play in the body that Initiatives of Change (IofC) was seeking to form in which the various business initiatives of IofC could merge as one entity under the name, "Initiatives of Change for Business and the Economy" (ICBE). The changing definition of business was discussed and ICBs approach in the merger efforts. They also considered ICBEs request for the support of the existing ICB Secretariat and other such matters.

At the meeting, there was a lot of sharing of information. The appointment of a representative from lofC Association to be a part of the team considering the formation of ICBE was one of them.

The Pune Chapter's hold its plan to workshop second "Reinventing on Organisations" with leaders from business another. The was workshop is planned to be held on January 5, 2019 at the Forbes Marshall conference room. They expect MDs of businesses from the small and medium sectors participate in the workshop.



Other matters such as possible visits to Jamshedpur and Mumbai were also looked at with the hope that through these visits, Chapters in these cities could also be strengthened. One of the thoughts were that a possible visit to the steel city, sometime in early 2019, should precede the visit to the country's financial capital.

Concluding the meeting, Sarosh Ghandy thanked Farhad for his time and hospitality, wondering if sometime in late January they could probably meet again.
